

President's Message

An Issue of Missed Communication

Dear Colleagues,

With fall in full swing, and everyone busy with work, school & family, I would like to take few moments to talk about communication.





Currently, our society has three main venues of communication. First, email. While email is cost-effective, its reach is declining by the day. When we send an email announcement, an open rate of 10%-20% is considered high! This means that we are only reaching 2 out of every 10 members. This is likely due to the ever increasing spam that drowns everything else out, and to the shift away from email by our younger members. Second, SMDS sends USPS snail mail announcements, membership renewals, and reminders. Physical mail is expensive, and time-consuming, yet it is the least effective method of communication. Most letters have to get past the front desk, the office manager, and the piles of mail to get to the doctor. Lastly, when all else fails, our staff often calls the doctor's office directly. Phone calls are time and labor-intensive, and we often run into the same issues of reaching the doctor. We are all busy people!

Wouldn't be great to communicate effectively, inexpensively, and to reach 95% of our members? Unlike the measly 10% email & snail mail open rate, SMS Text messaging has a 95+% read rate. Starting in 2019, SMDS will begin sending few important announcements (membership renewal reminders, early access to CE courses) via SMS Text Message to our members who have cell phone numbers on-file. We will continue with our email and snail mail flyers, and reserve Text messaging to important pertinent information that will not include advertising. Members can easily opt-out through a link that will be embedded in every message.

With the goal of better serving our members, Southern Maryland Dental Society will use SMS text-messaging for one year (calendar year 2019), and then continue or cancel the service based on feedback from our members. Happy Thanksgiving!





Dentist Day in Annapolis

February 20, 2019

In January, newly elected and re-elected members of the Maryland General Assembly will take the oath of office and affirm to, "be faithful and bear true allegiance to the state of Maryland." This oath is a sacred trust between our legislators and us, their constituents.

A renewed oath means a new General Assembly and new committee assignments, new chairpersons and new staff. It also requires an even stronger commitment by us, as organized dentistry, to get out and talk with new legislators along with those we already have established relationships.

I can't stress enough the importance of reaching out to your legislators NOW. We can't wait until January, or even February at Dentist Day to begin introducing ourselves. By January, the Legislative Affairs Committee and our lobbyists will already have begun reviewing many of the approximately 3,000 bills that will be introduced. And, by Dentist Day in Annapolis on Feb. 20, when our dentists mobilize at the State Capitol for a day of lobbying, we'll likely be starting to testify on bills important to our profession.

Dentist Day in Annapolis, however, is critical to showing our strength and the importance of our issues that are before the General Assembly. We urge all members of organized dentistry to attend this important event on Feb. 20, 2019.

It is our hope that between where you live and work, we will have Maryland dentists visit with the delegates and senators from all 47 legislative districts. Although you may not have an opportunity to meet with all your legislators in person, interacting with legislative staff and aides is often just as important and rewarding.

"Dentist Day" starts at 8am and runs until about 2pm. We meet on the ground floor of the historic Calvert House on State Circle in Annapolis for breakfast, welcoming remarks and legislator awards, and then we fan out to the legislative offices before meeting back up for lunch and a debrief. It's up to each of us to set up our own appointments with our legislators. So, it would be great if a group of dentists from one area could go as a team to your particular delegate or senator. We are happy to provide the contact information for your legislator, or you can go to the Maryland General Assembly's home page. Don't worry if it's your first time, as we'll help pair you up with a veteran dentist for your visits with legislators. We aim to make this day as easy and rewarding for you as possible and we will be sharing as much as possible as the day comes closer.

The visits are very congenial and we often talk about issues in our community as well as dental issues. It's also important to make sure your legislator knows that you and the MSDA are a resource to them should they ever need information during the legislative session. A follow up thank you note to your legislator after "Dentist Day" is always a nice touch.

We have a number of important issues to discuss with our delegates and senators including fee splitting, dental practice ownership, clinical decision making and access to oral care.

Register early by filling out the form found in this month's newsletter, or go online to the MSDA website, www.msda.com to get your spot reserved. A charge of \$50 is included to help defray some of the cost involved in providing such a worthwhile program. We had tremendous success last year both at Dentist Day and at hearings throughout the session because of the support of our member dentists. Please add MSDA Advocacy@msda.com to your contacts so you can stay up to date on our advocacy work this year. Your commitment to being in Annapolis and meeting with your legislators both at home and at the Capitol is critical to our success again this year.

Legislative Update 11/10/18

State Senator Paul Pinsky (D-PG County) will be attending the SMDS General Membership Meeting on 12/3/18. Senator Pinsky is the new chairman of the Senate Education, Health & Environmental Affairs Committee. This is a very important committee for they hear most bills concerning clinical dentistry. Chairman Pinsky is replacing Joan Carter-Conway (D-Baltimore City) who lost in the primary election. 12/3/18 is also SMDS Officer Visitation Night so it will be an exciting evening! Dentist Day in Annapolis is Wed. Feb. 20, 2019. Please save the date as this will be a relationship building year!

The MSDA is currently working on 3 bills to put forth in the 2019 legislative session:

- 1) **Task Force on Oral Health in Maryland.** We will reintroduce this bill to set up a Task Force to examine ways to remove barriers to dental services in the State. Senator Carter-Conway would not hold a hearing on the bill last session.
- 2) **Definition of Dental Practice Ownership & Management.** A bill to delineate between dental practice ownership and dental companies that provide services. It will include protections to not allow service companies from interfering in the dentist/patient relationship by owning dental practices in Maryland.
- 3) **Violations of the Maryland Dentistry Act** Penalties and Cease and Desist Orders. This bill would allow the MSBDE to go after individuals that practice without a license or who's license has been suspended. This bill passed the House last session but Senator Cater-Conway would not bring the bill to Senate Committee vote.

As many as 5 percent of all babies born in the US have tongue-ties significant enough to cause breastfeeding difficulties. Affected babies often fail to thrive and can be erroneously labeled as "lazy nursers" or "stubborn feeders".

Dr. Vitruk has authored 10 patents and over 20 articles on CO₂ lasers, and is a Member of The Institute of Physics, UK and a Diplomate of and Special Advisor on Laser Physics and Safety Education at the American Board of Laser Surgery.


