Earlier this year, the ADA launched an online search tool aimed to help prospective patients connect with local ADA member dentists. SMDS recently added the "Find a Dentist" service to our website under the "Public Services" section, so patients who visit our site can access this fantastic service.



The Find-a-Dentist tool is designed to help our members fill holes in their schedules by connecting to patients who are looking for a local dentist with ADA/MSDA and SMDS credentials. A person in our local area looking for a dentist can enter his or her street address or zip code and locate ADA/ MSDA/SMDS member dentists nearby. A variety of new search criteria are available to enhance the user experience, including payment options and dental specialty. The new patient can then contact the practice of his/her choice via email or phone to make an appointment.

A great bonus from the ADA is the inclusion of funding for paid search, ensuring that when targeted consumers look for a dentist on Google and other search engines, the ADA's Find-a-Dentist tool comes up toward the top. This ongoing "search engine optimization" equals free advertising to our members which would typically cost each practice hundreds of dollars a year to implement.

To take full advantage of the Find-a-Dentist ADA initiative, please take a few moments to fill out your Find-a-Dentist online profile. It will take about five minutes to complete. Keep in mind that ADA member dentists with completed profiles, especially those with photos, are prioritized in the online tool's search results. Profiles with photos receive 11 times more clicks on average than those without. You will be able to track how many times your profile has been viewed through 'My ADA member dashboard.'


