President's Message

Is Dentistry a Science?

That was the tag line for an article in the May 2019 issue of the Atlantic titled "The Truth About Dentistry." It got picked up by many news outlets around the country. It chronicles the journey of a few patients of Dr. John Roger Lund, a dentist in California.



According to the Article, Dr. Lund had clearly abused the doctor-patient trust. He routinely over-treated his patients, not only recommending unnecessary procedures but also charging for procedures that were not performed. He was eventually sued by patients, insurance companies and Dr. Zeidler, the dentist who had purchased his practice.



According to the Article, Dr. Zeidler was the opposite of his predecessor. He was ethical and disclosed his findings of overtreatment and over-billing to Lund's former patients. These were the facts in the article, an unethical dentist, driven by greed, exposed by an ethical dentist who put the health of his patients first, and refused to follow the same unethical route. Unfortunately, the article did not draw that conclusion. It painted the entire profession as unscientific, leaving treatment decisions to the whims of each doctor.

There has been some confusion regarding an advertisement piece sent by DOCS education to our area dentists (see image below).

The mailer is designed to sell you CE courses without real clarification of the licensing requirements. More specifically, the advertisement creates confusion regarding the requirements for prescribing Valium (Diazepam) by licensed dentists. For example, the ad states that programs are available that meet the “requirements” for adult anxiolysis and moderate sedation.

Dr. Arthur Jee of the Maryland State Board of Dental Examiners has kindly reached out to us to make matters clear. Please see the Board’s message below.


Maryland Dental Regulation §10.44.12.08(D)(1) requires dentists to complete at least 24 hours of instructive classroom training with 20 clinical patient experiences and obtain a Class 1 permit before providing patients with moderate sedation using any oral sedative (incl. Valium).*

Clinically-tested and up-to-date adult anxiolysis and moderate oral sedation training programs are being taught in **Washington, DC (May 17-19, 2019)** and **Memphis, TN (Aug. 16-18, 2019)** that each meet these requirements.

Special sessions regarding patient assessment, airway management, medical emergencies, anatomy, physiology, pharmacology, documentation, certification, monitoring, inventory, and dispensing of medications are also included.

These courses provide up to 25 hours of CE credits and may be used to fulfill CE requirements for license renewal. DOCS Education is an AGD PACE provider since 2000 [#217651].

** Dentists in Maryland who provide oral moderate sedation without required training and a permit could incur fines and reprimands.*

CLARIFICATION: MARYLAND ANESTHESIA AND SEDATION REQUIREMENTS

In the April 2019 edition of the Oracle, there were confusing statements regarding requirements for the use of anesthesia beyond local anesthesia. Please see the clarification below.

- 1. All licensed dentists may use nitrous oxide without the need for an anesthesia permit.**
- 2. All dentists may practice "ANXIOLYSIS" without the need for an anesthesia permit. ANXIOLYSIS which is intended to decrease anxiety, includes a single dose of one sedative, narcotic, class of drugs, or medication prescribed by the treating dentist and taken the evening before the procedure or the morning of a procedure, or both. The use of the same drug or another drug is acceptable. However, it is one dose and one drug. For example, it can be a single dose of Valium (Diazepam) in evening and a single dose of Halcion (Triazolam) in morning. The one drug, one dose along with Nitrous Oxide is still 'Anxiolysis'.**
- 3. All dentists practicing "MODERATE" sedation are required to have a CLASS I Anesthesia permit. This is the use of more than one drug either in the evening or morning. For example, if Halcion and Valium (or narcotic or any other medication for sedation) are used together either in the evening or morning, or both in the evening and morning. IT IS MODERATE SEDATION!!!**
- 4. Requirements for obtaining a MODERATE Sedation permit are contained in the Board's statutes and regulations. The educational requirements are 24 hours of didactic and 20 hours of observation. In addition, there are other requirements. Please contact the Maryland State Board of Dental Examiners for further details.**

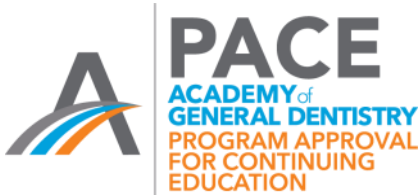

Course Objectives:

This 2 part course provides an expansive, contemporary, and in-depth summary of pediatric dentistry. Topics to be discussed include prevention, silver diamine fluoride (SDF), treatment planning, restorative dentistry and materials, space maintenance, pediatric dental emergencies and trauma, non-pharmacologic and pharmacologic behavior guidance and vital and non-vital pulp therapy.

Introduction: Enhance your understanding of the issues of pediatric laser dentistry, including tongue-ties and lip-ties! As many as 5 percent of all babies born in the US have tongue-ties significant enough to cause breastfeeding difficulties. Affected babies often fail to thrive and can be erroneously labeled as "lazy nursers" or "stubborn feeders".

A good surgical laser for cutting soft tissue must be able to vaporize soft tissue, while at the same time efficiently coagulating surgical margins. Not all laser wavelengths are suitable to comply with both requirements. This course focuses on the practical aspects of soft tissue laser surgery and on the fundamental processes involved in the laser-tissue interaction; it helps attendees learn how deep the laser beam cuts and how deep the coagulation and hemostasis extend into the surgical margins. Our **hands-on participation lab** is designed to train attendees on what surgical lasers can do safely and efficiently.

Clinical Curriculum:

- Demonstrate a wide range of didactic and clinical tools for the use of lasers in pediatric dentistry
- Present basic knowledge about Dental lasers adhering to the established standards of education
- Instruct Dentists, Lactation Consultants, Speech and Language Therapists, and other allied health care providers to understand the efficient and safe application of laser energy in everyday practice
- Provide sound scientific basis and proven efficacy of use of lasers in Dentistry in order to ensure public safety
- Explore current methods of clinical assessment, diagnosis and treatment of lingual and labial ties Attendees will be able to:
 - Understand infant sucking physiology and how tongue ties impair infant suck;
 - Use reliable diagnostic criteria to screen babies for this condition; and
 - Understand all consequences and benefits of using lasers to remove oral restrictions
- Through participation in a hands-on workshop, the course attendees will learn to remove oral restrictions using soft-tissue lasers
- Explore current methods of identification of TOTS for diagnosis, treatment, and management
- Demonstrate two different practice models to integrate TOTS therapy into various practice settings

Laser Curriculum:

Laser Surgery and Safety Basic Knowledge Certification Curriculum for this Course has been developed by the American Laser Study Club (ALSC). The ALSC's curriculum overcomes the known limitations of many laser dentistry courses, and includes the detailed physics of soft tissue ablation and coagulation with laser and hot tip (non-laser) devices. Laser hands-on wetlab on tissue samples will include different laser wavelengths and will include laser safety instructions and demonstrations. Laser instructions will be assisted by guest speaker Peter Vitruk, PhD, MInstP, CPhys, DABLS, a laser physicist who founded the American Laser Study Club and LightScalpel LLC.
