MARVIN LEVENTER, DDS

MARVIN LEVENTER RECEIVED HIS DENTAL DEGREE FROM THE UNIVERSITY OF MARYLAND IN 1990. HE THEN COMPLETED A TWO YEAR GENERAL PRACTICE RESIDENCY, AND A TWO YEAR DENTAL ANESTHESIOLOGY RESIDENCY AT BROOKDALE HOSPITAL MEDICAL CENTER IN NEW YORK. DR. LEVENTER IS A DIPLOMAT OF THE AMERICAN DENTAL BOARD OF ANESTHESIOLOGY AND A FELLOW OF THE AMERICAN DENTAL

SOCIETY OF ANESTHESIOLOGY. HE IS ALSO A MEMBER OF THE AMERICAN SOCIETY OF DENTIST ANESTHESIOLOGISTS, AND THE ACADEMY OF GENERAL DENTISTRY. DR. LEVENTER IS COMMITTED TO PROVIDING HEALTH-ORIENTED DENTAL CARE WITHOUT PAIN OR ANXIETY.

DR. LEVENTER HAS BEEN A PART TIME CLINICAL INSTRUCTOR IN DENTAL ANESTHESIOLOGY AT THE UNIVERSITY OF MARYLAND DENTAL SCHOOL SINCE 1997, AS WELL AS MAINTAINING A FULL TIME PRIVATE GENERAL DENTAL PRACTICE. SINCE 2009 HE HAS BEEN A FULL TIME ASSISTANT PROFESSOR IN DENTAL ANESTHESIA AT THE UNIVERSITY OF MARYLAND, AND PROVIDES GENERAL DENTISTRY WITHIN SCHOOL'S FACULTY PRACTICE. HE HAS LECTURED FOR MANY DENTAL GROUPS ON THE USE OF ANESTHESIA IN DENTISTRY.



RICHARD WYNN, PHD

RICHARD L. WYNN, PHD IS PROFESSOR OF PHARMACOLOGY AT THE DENTAL SCHOOL, UNIVERSITY OF MARYLAND, BALTIMORE. HE EARNED THE BS IN PHARMACY, MS IN PHYSIOLOGY AND PHD IN PHARMACOLOGY ALL FROM THE UNIVERSITY OF MARYLAND. HE PRACTICED PHARMACY FOR 10 YEARS IN THE BALTIMORE AREA. HE CHAIRED THE DEPARTMENT OF PHARMACOLOGY FROM 1980 TO 1995 AND BIOCHEMISTRY FROM 1990 TO 1995 AT THE UNIVERSITY OF MARYLAND DENTAL SCHOOL. PREVIOUSLY HE CHAIRED THE DEPARTMENT OF ORAL BIOLOGY AT THE UNIVERSITY OF

KENTUCKY DENTAL SCHOOL IN LEXINGTON. HIS RESEARCH LABORATORIES HAVE CONTRIBUTED TO DEVELOPMENT OF INHALANT AND INTRAVENOUS ANESTHETICS, AND AGENTS FOR CONTROL OF CHEMOTHERAPY-INDUCED NAUSEA. HE HAS TO HIS CREDIT OVER 400 PUBLICATIONS INCLUDING ORIGINAL RESEARCH ARTICLES, TEXTBOOKS, BOOK CHAPTERS, AND MONOGRAPHS. HE HAS GIVEN CONTINUING EDUCATION SEMINARS SINCE 1975 TO DENTAL PROFESSIONALS IN THE US, CANADA, MEXICO AND EUROPE. HE IS THE LEAD AUTHOR AND CHIEF EDITOR OF DRUG INFORMATION HANDBOOK FOR DENTISTRY, NOW IN ITS 23RD EDITION, PUBLISHED BY LEXICOMP, INC. HIS PAST CONSULTING HAS INCLUDED THE PHARMACEUTICAL INDUSTRY, THE ACADEMY OF GENERAL DENTISTRY, THE AMERICAN DENTAL ASSOCIATION, AND THE MARYLAND STATE BOARD OF DENTAL EXAMINERS. HIS CHIEF INTEREST IS IN TEACHING PHARMACOLOGY TO DENTAL AND DENTAL HYGIENE STUDENTS, AND IN KEEPING DENTAL PROFESSIONALS INFORMED OF CURRENT AND NEW DRUG INFORMATION RELATIVE TO DENTAL PRACTICE.

Course Objectives:

THIS INTENSIVE 24-HOUR COURSE IS OFFERED TO THE DENTIST FOR TRAINING IN THE SAFE AND EFFECTIVE USE OF COMBINED INHALATION-ENTERAL CONSCIOUS SEDATION IN THE ADULT DENTAL PATIENT.

THIS COURSE WILL FOLLOW OBJECTIVES AND COURSE CONTENT BASED ON THE CURRENT AMERICAN DENTAL ASSOCIATION (ADA) GUIDELINES FOR TEACHING COMBINED INHALATION-ENTERAL CONSCIOUS SEDATION (COMBINED CONSCIOUS SEDATION). THIS INFORMATION IS DESIGNED TO COVER MATERIAL NECESSARY TO APPLY FOR A CLASS I SEDATION PERMIT IN MARYLAND. THIS CASE-BASED COURSE WILL OFFER IN-DEPTH DISCUSSION OF EACH ASPECT OF THE SEDATION REGIMEN INCLUDING SCENARIOS OF HOW TO DO THINGS CORRECTLY AS WELL AS WHAT CAN GO WRONG. CASE REVIEWS AND PUBLISHED REPORTS WILL BE PRESENTED WITH QUESTION AND ANSWER PERIODS. ALL THE OBJECTIVES IN THE ADA GUIDELINES WILL BE COVERED AND A COMPREHENSIVE SET OF REFERENCE MATERIALS WILL BE PROVIDED AS A HANDOUT.

THE FOLLOWING IS A BRIEF SYNOPSIS OF INCLUDED MATERIAL: PRESENTATION OF 20 VIDEOS OF ACTUAL SEDATION CASES; PATIENT EVALUATION AND SELECTION; DESCRIPTION OF THE CNS LEVELS RANGING FROM THE CONSCIOUS TO UNCONSCIOUS; THE TECHNIQUE OF PHARMACOLOGICAL-INDUCED SEDATION USING NITROUS OXIDE AND APPROPRIATE SEDATIVE DRUGS SUCH AS HALCION; A REVIEW OF RESPIRATORY AND CIRCULATORY PHYSIOLOGY AND AIRWAY MANAGEMENT; THE PHARMACOLOGY OF THE BENZODIAZEPINES AND OTHER COMMONLY USED SEDATIVE DRUGS AND THEIR INTERACTIONS; INDICATIONS, PROCEDURES, AND CONTRAINDICATIONS FOR THE USE OF CONSCIOUS SEDATION; PROPER PATIENT MONITORING AND NECESSARY EQUIPMENT; RECORD KEEPING, PATIENT INSTRUCTIONS AND PREPARATION; MEDICAL EMERGENCY PREPAREDNESS; A REVIEW OF LOCAL ANESTHESIA AS RELATED TO SEDATION; PROPER USE OF INHALATION SEDATION EQUIPMENT AND HAZARDS OF TRACE GASES; AND FINALLY THE ABUSE POTENTIAL AND HALLUCINATORY EFFECTS OF SEDATIVE DRUGS.

DR. WYNN AND DR. LEVENTER HAVE PRESENTED THIS 3 DAY COURSE COURSE 7 TIMES INCLUDING ONE SPONSORED BY THE ACADEMY OF GENERAL DENTISTRY. THEY HAVE AS WELL PRESENTED THIS INFORMATION IN A RENEWAL FORMAT 5 TIMES.

ANY PORTION OF THIS COURSE CAN BE TAKEN INDEPENDENTLY FOR LICENSE OR SEDATION PERMIT RENEWAL CREDITS. AS WELL, THE 2-HOUR BOARD REQUIRED COURSE FOR PRESCRIPTION WRITING AND DRUG DISPOSAL IS INCLUDED.
