I am hopeful this change will ease workforce shortages that we are facing and also meet the changing demographics in our patient base. This is especially meaningful to me as a radiology instructor because I have witnessed this first-hand. The need for testing and educational materials to meet student needs is present. While there are translation apps, my hope is that textbooks will be translated to other languages to help further support. In the future, DANB plans to offer the RHS in more languages as a means to renew lost dental assistants. It is undeniable that workforce diversity bridges communication gaps, improves patient care and patient satisfaction.

On a similar note, SMDS is recruiting interested members to join our Executive Board Committee. We hold 10 virtual meetings a year on Monday from 6:30-7:30pm. We are also seeking members who are interested in teaching in-person or virtually our dental assistant x-ray course. This course is taught several times throughout the year and is critical in educating dental assistants in the area. 


