Change in Continuing Education Requirements for Dentists and Dental Hygienists

THIS BULLETIN AMENDS THE PREVIOUS BULLETIN AND NOW INCLUDES THOSE WHO ARE SCHEDULED TO RENEW THEIR DENTAL OR DENTAL HYGEINE LICENSE IN 2027

These Frequently Asked Questions are intended to provide dentists and dental hygienists with a brief summary of the significant changes to the continuing education regulations that took effect on **March 3, 2025**. This document is not a comprehensive review of the regulations. You are strongly encouraged to read the attached regulations titled Code of Maryland Regulations (COMAR) 10.44.22 Continuing Education in their entirety. References are to the attached regulations.

What are the New Infection Control Course Requirements?

The required number of hours for the infection control course has increased from 2 to 3 hours. The infection control course must be taken as a condition of license renewal (.04M). The course must be a single 3-hour Board-approved course (.04BB). All courses must be Board-approved (.04A). The required number of continuing education hours remains at 30 (.04B).

What is the Time Frame for Completing Continuing Education?

Prior to the recent changes, the 2-year time to complete your continuing education ended on December 31st of the year preceding the year of your license renewal. The present period will coincide directly with the renewal period. Therefore, the new timeframe for completing continuing education extends for 2 years from July 1 through June 30 of the second year following the effective date of your renewal (.05).

.05 Time Frame for Completing Continuing Education.

- A. The period for completing continuing education requirements extends for a 2-year period from July 1 through June 30 of the second year following the effective date of the license.
- B. The 2-year period in which the continuing education shall be completed ends on June 30 of the year in which the license is due for renewal.
- C. For the renewal period beginning on June 1, 2025, only, the period for completing continuing education requirements extends for the period January 1, 2023, through June 30, 2025.



THE STUDY

Researchers are interested in looking at the oral bacteria and genotypes of people that present with periodontal disease at an early age (before age 35) or have a persistent decline in their periodontal status despite consistent and adequate oral hygiene care and treatment.

ELIGIBILITY

You May Qualify for This Study If You Are:

- At least 7 years of age
- Have been diagnosed with the disease periodontitis (gum disease)

You May Not Qualify If You:

- Have a history of an autoimmune disorder (such as lupus or rheumatoid arthritis)
- Are pregnant or breast feeding
- Have a bleeding disorder
- Have had radiation therapy to the head or neck
